VILLAGE OF BERRIEN SPRINGS ORDINANCE NUMBER 382

AN ORDINANCE TO AMEND CHAPTER 1 ENTITLED, "GENERAL PROVISIONS," Section 1-18 ENTITLED, "Municipal civil infraction ordinance and Municipal civil infraction actions and citations — Municipal ordinance violations bureau", "(a) Definitions", "Municipal civil infraction shall include the following offenses set forth in the Code as follows:"

NOW THEREFORE, The Village of Berrien Springs ordains:

- Section 1. Under Section 1-18 (a) Definitions, a Municipal civil infraction shall no longer include Chapter 12, Building and Building Regulations, Article II entitled, "Building Code", Sections 12-26 through 12-55. So the Restated item (3) shall be restated as follows:
- (3) Chapter 12, Building and Building Regulations, Sections 12-1 through 12-25 and Sections 12-56 through 12-184, and all amendments or additions to these sections.
- Section 2. Any and all other parts, sections or clauses contained in said Ordinance not otherwise amended by this Ordinance are hereby ratified and affirmed and remain in full force and effect.
- **Section 3.** This Ordinance and its various parts, sections and clauses are hereby declared several. If any part, section or clause contained in this Ordinance is adjudged unconstitutional or otherwise legally invalid, it is hereby provided that the remainder of the Ordinance shall not be affected thereby.
- **Section 4.** All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.
- **Section 5.** The Village Clerk shall certify to the adoption of this Ordinance and cause the same to be published as required by law.
- **Section 6.** This Ordinance shall take effect twenty (20) days after publication.
